This is to inform all concerned that, as per Clause 11.05 of the UGC (Institutions Deemed to be Universities) Regulations, 2023, dated 2nd June, 2023, the **Executive Council** of the Vidyapeeth was constituted in September 2023.

The first tenure of the Executive Council **members appointed by the Vice-Chancellor from the categories of Professor, Associate Professor, and Assistant Professor is one year** or until they cease to be teachers of the University, whichever is earlier. The tenure of the previous members was up to September 2024. The second tenure of the Executive Council **members appointed by the Vice-Chancellor from the categories of Professor, Associate Professor, and Assistant Professor is one year** or until they cease to be teachers of the University, whichever is earlier. The tenure of the previous members was up to September 2025.

As their tenure has now expired, **new members have been nominated to the Executive Council of the Vidyapeeth** for a remaining tenure of one year, commencing from **1st October 2025 to 25th September 2026**.

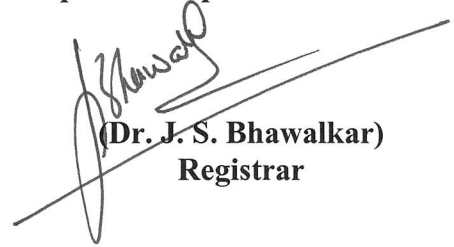
